



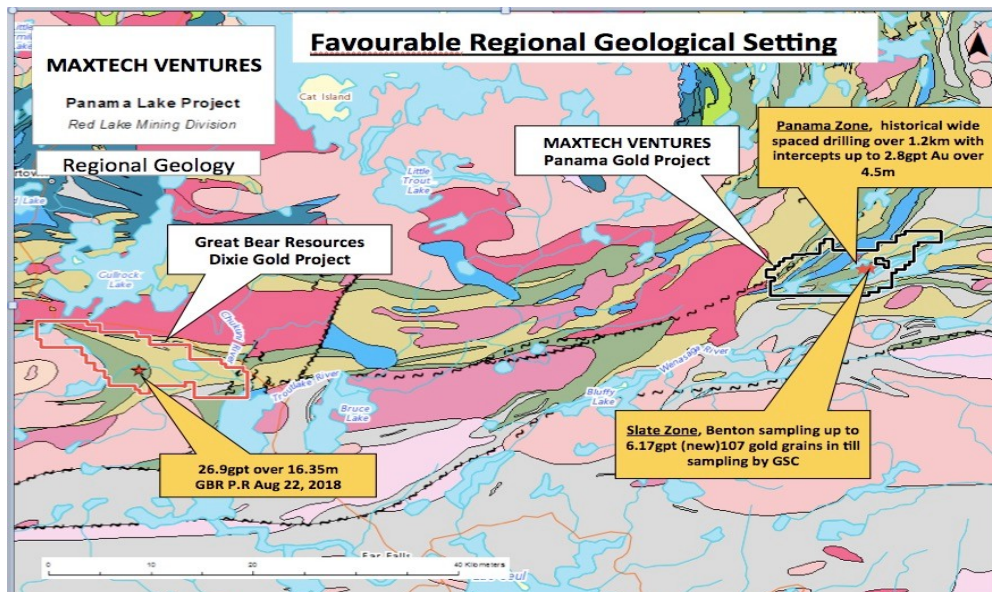
Maxtech Ventures Inc. (CSE:MVT, FSE:M1N, OTC:MTEHF) 探尋加拿大下一個高品位黃金發現區

收購高級階段勘探資產的初級勘探公司

項目：

本公司的旗艦Panama Lake黃金項目占地面積超過11,000公頃，位於加拿大安大略省世界級的Red Lake礦區，該礦區以富含高品位的黃金礦床聞名。

- 位於Great Bear Resources的“Dixie Lake”發現區以東60公里
- 與Great Bear Resources TSX: GBR處在同一趨勢帶上，地質構造也相同
- 該礦區迄今為止已經生產了2800多萬盎司黃金
- 良好的基礎設施，包括公路和熟練的勞動力
- 2018年鑽探活動見金品位1.58克/噸的7.6米礦段，確認了1989年Noranda Exploration的結果-金品位1.2克/噸的15米礦段，包括金品位2.8克/噸的4.3米礦段
- 安大略省地質調查局在Red Lake區內完成的冰碛物採樣活動獲得最高金粒數量地區之一就位於項目區內
- 2019年的地球物理勘測見到已知礦化結構，已經幫助探邊延伸區域和新的礦化結構趨勢帶/靶區，計劃2020年3月對這些區域進行鑽探，重點是在Great Bear Resources發現區的位置尋找同樣的隆起閉合
